According to an EU study, around 107500 refugees were migrated to Europe in July 2015. This is the first time that many refugees in Europe are illegally entered in a month. According to the study, Afghans make the majority of these illegal immigrants. The US Department of State's Human Trafficking Report 2015. The status of these refugees refers to "very bad" and in this regard, in a zone called Afghanistan, that the government does not take the necessary effort against human smugglers. Overall the immigration system in the world has been shattered and many refugees are from Europe, Middle East and Africa to Europe. What are the key reasons behind the international immigration and what is the status of the Afghan refugees in the world? Look at the following detail as well.

-- Syrian civil war: Syria's civil war, which started since 2011, took place in 2014, the world's most populous nation. There are still more than 4 million refugees. In 2014, 66698 people went through water to Europe. Also from the first month of 2015 to six months, Europe's largest part of the immigrant refugees made it illegal to Europe.

--Iraq's civil war and ISIS group: After the withdrawal of Americans from the Iraqis, the civil war was shattered, which is still ongoing and therefore a number of people went to Europe to migrate. After that, when the "Islamic State" group emerged in Iraq, a number of Yazidis of this country also moved to Europe. Although there is no scope for this, many "Islamic State" groups fled to Europe after the transition of the government; But Turkey started the Turkish border on the eve of September 2014 and is now about 30 thousand as Azedan residents are likely to have

some of them going to Europe from Turkey's trafficking trains.

Afghanistan: Afghanistan is the main causes of insecurity and unemployment in Afghanistan that Afghans need to migrate to Europe (detailed detail below the Afghan case), Various factors of African countries: Last year, 170,000 were expelled from Europe to Europe, and about 21,000 Africanis arrived in Europe from the beginning of April 2015. First: In European countries, clashes between existing refugees and local people were created and anti-migrations were created. For instance, the British National Party comprises the French Front Sweden Democrats, Germany Peoples and other parties.

Second: After the Arab spring, the civil war began in the Middle East, in many African countries, due to lack of dictatorships, diseases, and economic problems in Afghanistan, as well as many international refugees returning to Europe and by increasing these factors, the number of refugees also increases to Europe. Only in July 2015, more than a million refugees were migrated to Europe and estimates that only eight locks of return to Germany came to Germany.

Third: The majority of the refugee boats were drowned in the Mediterranean sea, due to which 3072 people were killed in 2014 alone. According to the Telegraph newspaper, this figure has risen since 2000 in the current year. Last week, a boat was drowned in the ocean and 49 were killed. This situation also has changed the migration system into a crisis.

Fourth: Most countries have created tough policies against migrants and often do not accept illegal migrants. For example, Hungary has imposed an influence on its border with Serbistan on the migration of refugees. In addition, the economic crisis in Europe has also played its role in it.

Afghanistan immigration reasons

If you look at the figures for the past two years, it would be clear that most of the country's people has gone to Europe illegally. Although it is very difficult to find out how many Afghans each year visit Europe, but some agencies surveyed this year and according to a survey, around 26215 people in 2013 Europe had offered asylum seekers. This number again rose to 41370 in 2014 and in the current year, the oblivious factors of the immigration increase increased, the day the number of people moving to the country increases.

It has been the main factors under the past few years and especially for a year, Afghans are trying to withdraw the country more than any other time:

1. Lack of security and warfare

If the past five years have passed, the war is annoyed every year; but in the last year the war has been very strong. Also, after the signing of the Security Treaty, the blast began in the country's capital, especially after the announcement of

the death of Mullah Omar's age, further emphasized the war against various invaders

According to a UNAMA report, approximately 5,000 civilians were killed in various bombings and conflicts since the beginning of 2015.

Nevertheless, Pakistan, Iran, and many other countries, do not have immovable cultural status, but poor human rights abuses.

The registered refugees also return to Afghanistan, but they are still looking forward to staying in Pakistan in 2015. Of course, after 2015, they are also facing a black collapse, or will extend the duration of their cards, or will be left indefinitely and will be forced to withdraw, to return to their country.
